ABSTRAK

Penelitian ini bertujuan untuk (1) Mengetahui dan menganalisa implementasi pasal 303 KUHP juncto pasal 2 Ayat 1 UURI No 7 Tahun 1974 Tentang Penertiban Perjudian terhadap perjudian sabung ayam (*tajen*) di Kabupaten Buleleng, (2) Mengetahui dan menganalisa upaya penyidik dalam mencegah terjadinya tindak pidana perjudian terhadap perjudian sabung ayam (*tajen*) di Kabupaten Buleleng. Adapun jenis penelitian yang digunakan adalah penelitian hukum empiris, dengan sifat penelitian deskriptif dengan lokasi penelitian dilaksanakan di Sat Resrim Polres Buleleng, Kejaksaan Negeri Buleleng pada seksi tindak pidana umum, dan Majelis Hakim di Pengadilan Negeri Singaraja Kelas 1B serta beberapa tokoh masyarakat di Kabupaten Buleleng dan didukung dengan para pelaku Narapidana pada tindak pidana perjudian sabung ayam (*tajen*) di Lembaga Pemasyarakatan Kelas IIB Singaraja. Teknik pengumpulan data yang digunakan adalah dengan studi dokumen, observasi, dan wawancara. Teknik penentuan sampel yang digunakan adalah teknik Non Probability Sampling dan penentuan subjeknya menggunakan teknik Purposive Sampling. Teknik pengolahan dan analisis data secara kualitatif. Hasil penelitian menunjukkan bahwa (1) Implementasi pasal 303 KUHP juncto pasal 2 Ayat 1 UURI No 7 Tahun 1974 Tentang Penertiban Perjudian terhadap perjudian sabung ayam (*tajen*) di Kabupaten Buleleng ini belum dapat dinyatakan berjalan efektif yang menyebabkan, kurang tegasnya aparat penegak hukum dan kurangnya kesadaran bagi masyarakat serta (2) Upaya penyidik dalam mencegah terjadinya tindak pidana perjudian terhadap perjudian sabung ayam (*tajen*) di Kabupaten Buleleng terdapat dua upaya efektif yaitu upaya represif dan upaya preventif.

ABSTRACT

This study aims to (1) determine and analyze the implementation of Article 303 of the Criminal Code in conjunction with Article 2 Paragraph 1 UURI No. 7 of 1974 concerning Gambling Control against cockfighting (*tajen*) gambling in Buleleng Regency, (2) Knowing and analyzing the efforts of investigators in preventing crime. gambling crime against cockfighting (*tajen*) gambling in Buleleng Regency. The type of research used is empirical legal research, with the nature of descriptive research with the research location being carried out at the Buleleng Police Resrim Unit, the Buleleng District Prosecutor's Office in the general crime section, and the Panel of Judges at the Singaraja District Court Class 1B as well as several community leaders in Buleleng and supported by the perpetrators of convicts in the crime of cockfighting gambling (*tajen*) at the Singaraja Class IIB Penitentiary. Data collection techniques used are document studies, observations, and interviews. The sampling technique used is the Non-Probability Sampling technique and the subject is determined using the Purposive Sampling technique. Qualitative data processing and analysis techniques. The results showed that (1) the implementation of Article 303 of the Criminal Code in conjunction with Article 2 Paragraph 1 UURI No. 7 of 1974 concerning Gambling Control against cockfighting (*tajen*) gambling in Buleleng Regency has not been declared effective because it is caused by the lack of firmness of law enforcement officials and lack of awareness for the community and (2) Investigators' efforts in preventing the occurrence of *gambling crimes against cockfighting gambling (tajen) in Buleleng Regency there are two effective efforts, namely repressive efforts and preventive efforts.*
