**ABSTRAK**

Penelitian ini bertujuan guna menganalisis pelaksanaan peran dari Kepolisian dalam upaya penanggulangan terhadap sebuah tindak pidana perjudian toto gelap di Kabupaten Buleleng serta faktor penghambat dari upaya Kepolisian untuk menangani hambatan-hambatan yang di alami oleh pihak kepolisian dalam upaya penanggulangan tindak pidana perjudian toto gelap angka di Kabupaten Buleleng. Jenis penelitian menggunakan penelitian hukum empiris. Didalam penelitian ini bersifat deskriptif. Lokasi penelitian ini di lakukan di Kepolisian Resor Buleleng. Subjek dari penelitian ini yaitu kepolisian yang memiliki wewenang di dalam menegakkan hukum terhadap praktik perjudian toto gelap angka di wilayah hukum Kabupaten Buleleng yaitu di dalam hal ini anggota dari Res. Pidana Umum Polres Buleleng. Tehnik pengumpulan data yang di lakukan dengan cara observasi, wawancara serta studi sokumen. Hasil wawancara menunjukkan bahwa upaya dari Kepolisian Resor Buleleng dalam menanggulangi perjudian di Kabupaten Buleleng belum maksimal. Dikarenakan Unit I Pidana Umum selaku unit yang menangani tentang perjudian mengalami kekurangan personil sehingga yang dapat di lakukan hanya mengadakan patroli saja. Adapun faktor penghambat kepolisian dalam menanggulangi tindak pidana perjudian toto gelap diantaranya adalah tempat perjudian yang berpindah-pindah, bandar judi susah di temukan serta masyarakat tidak kooperatif memberikan informasi kepada pihak Kepolisian.

*ABSTRACT*

*This study aims to analyze the implementation of the role of the Police in efforts to tackle an illegal toto gambling crime in Buleleng Regency as well as inhibiting factors from the Police's efforts to deal with obstacles experienced by the police in an effort to tackle the illegal toto gambling crime in Regency Buleleng. This type of research uses empirical law research. In this research is descriptive. The location of this research was conducted at the Buleleng Resort Police. The subject of this research is the police who have the authority in enforcing the law against the practice of gambling on illegal numbers in the legal area of the Regency of Buleleng, in this case a member of the Res. Criminal General Police Buleleng. Data collection techniques are carried out by means of observation, interviews and document study. The interview results show that the efforts of the Buleleng Police Department in dealing with gambling in Buleleng Regency have not been maximized. Because Unit I of the Public Crime as a unit dealing with gambling experiences a shortage of personnel so that what can be done is only to conduct patrols. The inhibiting factors of the police in tackling the illegal gambling gambling crime are among the places where gambling is on the move, bookies are hard to find and the community is not cooperative in providing information to the Police.*
