ABSTRAK

Riset ini ditujukan dalam rangka implementasi pengamanan hukum yang dilaksanakan oleh Pusat Pelayanan Terpadu Pemberdayaan Perempuan dan Anak Kabupaten Buleleng untuk anak sebagai korban kekerasan. Riset yang peneliti terapkan dalam riset ini yakni yuridis empiris dengan sifat penelitian deskriptif. Riset ini dilaksanakan di Pusat Pelayanan Terpadu Pemberdayaan Perempuan dan Anak Kabupaten Buleleng. Mengenai teknik pengumpulan data, teknik *non-probability* sampling dilaksanakan dalam wujud teknik *purposive sampling*. Perolehan riset mengatakan bahwasanya melakukan perlindungan hukum bagi anak korban kekerasan dapat dilaksanakan dengan baik, namun belum sempurna. Hal ini ditunjukkan dengan pemograman yang dilaksanakan oleh Badan Pelayanan Terpadu untuk memberdayakan perempuan dan anak. Namun, banyak program yang tidak dapat dilaksanakan dikarenakan terbatasnya keuangan serta sumber daya manusia yang mumpuni.

ABSTRACT

This study aims to determine the implementation of legal protection carried out by the Integrated Service Center for Women and Children Empowerment of Buleleng Regency for children as victims of violence. The type of research used in this research is empirical juridical with descriptive research nature. This research was conducted at the Integrated Service Center for Women and Children Empowerment of Buleleng Regency. Related to data collection techniques carried out with Non Probability Sampling techniques with the form of purposive sampling techniques. The results showed that the implementation of legal protection for children as victims of violence has been going well but cannot be said to be perfect. This is evidenced by the programs carried out by the Integrated Service Center for the Empowerment of Women and Children. However, many programs have not been implemented due to limited funds and human resources in their fields.
