ABSTRAK

Penelitian ini bertujuan untuk mengetahui (1) peran kepolisian resor Buleleng dalam upaya menanggulangi tindak pidana pencabulan pada anak di kabupaten Buleleng dan (2) menganalisa terkait kendala yang dialami oleh Kepolisian Resor Buleleng dalam penanggulangan tindak pidana pencabulan pada anak di Kabupaten Buleleng. Jenis penelitian yang digunakan yakni penelitian hukum empiris dimana sebagai penelitian yang mengacu karena adanya kesenjangan antara *das solen* dan *das sein* yakni kesenjangan antara teori dan realita yang terjadi di lapangan. Sifat penelitian yakni bersifat deskriptif dan sumber data berasal dari data primer melalui penelitian lapangan di Kepolisian Resor Buleleng serta menggunakan data sekunder. Adapun teknik pengumpulan data yang digunakan yakni teknik studi dokumen, observasi dan teknik wawancara dengan menggunakan teknik *purposive sampling*. Hasil penelitian menunjukkan (1) upaya yang dilakukan Kepolisian Resor Buleleng dalam menanggulangi tindak pidana pencabulan pada anak di Kabupaten Buleleng yaitu upaya *pre-emptif*, *preventif* dan upaya *represif*. (2) hambatan yang dialami oleh kepolisian dalam menanggulangi tindak pidana pencabulan yakni sulitnya melakukan pemblokiran akses pornografi yang sudah bermacam ragam cara untuk mengakseskannya, kurangnya personil polisi wanita (polwan), dan korban enggan mengatakan kejadian sebenarnya serta tidak adanya saksi

ABSTRACT

*This study aims to determine (1) the role of the Buleleng Resort Police in efforts to deal with criminal acts of sexual abuse of children in Buleleng Regency and (2) to analyze the obstacles experienced by the Buleleng Resort Police in overcoming criminal acts of sexual abuse of children in Buleleng Regency. The type of research used is empirical legal research which refers to research because of the center of attention between *das solen* and *das sein*, namely the prominence between theory and reality that occurs in the field. The nature of the research is descriptive in nature and the source of the data comes from primary data through field research at the Buleleng Police and using secondary data. The data collection techniques used were document study techniques, observation and interview techniques using purposive sampling techniques. The results of the study show (1) the efforts made by the Buleleng Police in tackling criminal acts of sexual abuse of children in Buleleng Regency, namely pre-emptive, preventive and repressive efforts. (2) Obstacles experienced by the police in overcoming criminal acts of obscenity are the difficulty in blocking access to pornography which has various ways to access it, the lack of female police personnel (policewomen), and the victim's reluctance to tell the truth and the absence of witnesses*
