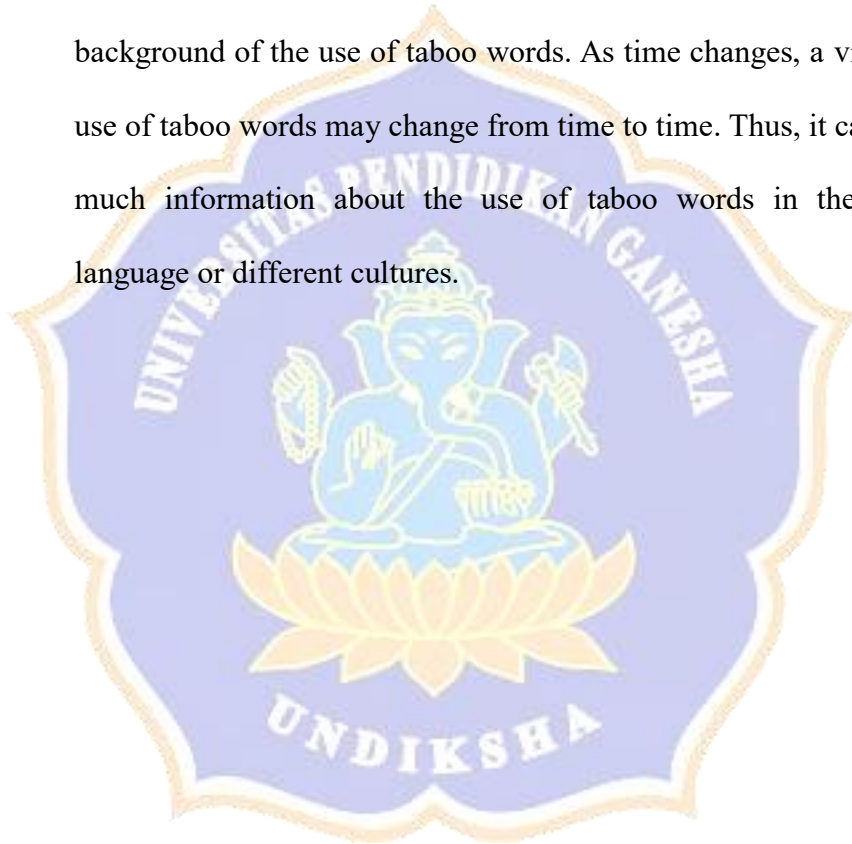


**b. For Other Researcher**
