

**IMPLEMENTASI PERATURAN DAERAH KABUPATEN BULELENG
NOMOR 6 TAHUN 2015 TENTANG PENATAAN DAN
PEMBERDAYAAN PEDAGANG KAKI LIMA DI KOTA SINGARAJA**

Abstrak

Penelitian ini memiliki tujuan untuk, (1) Untuk mengetahui implementasi Peraturan daerah kabupaten buleleng nomor 6 tahun 2015 tentang penataan dan pemberdayaan peagang kaki lima di kota singlaraja. (2) Menganalisis faktor penghambat yang dihadapi pihak satuan polisi pamong praja kabupaten buleleng dalam penerapan peraturan daerah kabupaten buleleng nomor 6 tahun 2015 tentang penataan dan pemberdayaan pedagang kaki lima di kota singlaraja. Penelitian ini merupakan penelitian hukum empiris, yang bersifat deskriptif kualitatif. Data diperoleh melalui observasi, studi dokumen, dan wawancara. Metode pengambilan sampel dalam penelitian ini menggunakan *Non Probability Sampling*, jenis *Non Probability Sampling* yang di terapkan yaitu *Purposive Sampling*. Penelitian ini didukung dengan bahan hukum yang terdiri dari peraturan perundang-undangan, jurnal, artikel, literatur-literatur serta karya tulis ilmiah yang relevan. Data yang terkumpul dianalisis melalui analisis kualitatif. Hasil penelitian menunjukkan bahwa: (1) Penerapan peraturan daerah nomor 6 tahun 2015 tentang penataan dan pemberdayaan pedagang kaki lima di kota singlaraja belum maksimal dalam penerapannya baik secara substansi maupun strukturnya. (2) Faktor penghambat yang dihadapi satuan polisi pamong praja dalam penerapan perda nomor 6 tahun 2015 tantang penataan dan pemberdayaan pedagang kaki lima di kota singlaraja yaitu dari segi sikap mental menjadi salah satu hambatan terbesar dalam penerapan peraturan ini, masih kurangnya kesadaran masyarakat khususnya para pedagang kaki lima.

Abstrcak

This research aims to: (1) To find out the implementation of Buleleng Regency Regional Regulation number 6 of 2015 concerning the arrangement and empowerment of street vendors in the city of Singaraja. (2) Analyze the inhibiting factors faced by the Buleleng district civil service police unit in implementing Buleleng district regional regulation number 6 of 2015 concerning the arrangement and empowerment of street vendors in the city of Singaraja. This research is empirical legal research, which is descriptive qualitative in nature. Data was obtained through observation, document study and interviews. The sampling method in this research used Non Probability Sampling, the type of Non Probability Sampling applied was Purposive Sampling. This research is supported by legal materials consisting of statutory regulations, journals, articles, literature and relevant scientific papers. The collected data was analyzed through qualitative analysis. The research results show that: (1) The implementation of regional regulation number 6 of 2015 concerning the arrangement and empowerment of street vendors in the city of Singaraja has not been optimal in its implementation, both in substance and structure. (2) The inhibiting factor faced by the civil service police unit in implementing regional regulation number 6 of 2015 regarding the arrangement and empowerment of street vendors in the city of Singapore, namely in terms of mental attitude, is one of the biggest obstacles in implementing this regulation, there is still a lack of public awareness, especially for traders. Street vendor.
