ABSTRAK

Penelitian ini bertujuan untuk mengetahui upaya yang dilakukan Polres Buleleng dalam menangani dan menindak pelaku penyebar video bermuatan asusila disertai pemerasan dan pengancaman Kabupaten Buleleng dan kendala yang dihadapi oleh Polres Buleleng dalam menindak pelaku penyebar video bermuatan asusila disertai pemerasan dan pengancaman di Kabupaten Buleleng. Penelitian ini di latarbelakangi oleh tindak pidana penyebaran video bermuatan asusila disertai pemerasan dan pengancaman yang semakin terjadi dari tahun ke tahun di Kabupaten Buleleng, serta dampak yang ditimbulkan akibat dari terjadinya tindak pidana penyebaran video bermuatan asusila disertai pemerasan dan pengancaman bagi masyarakat luas. Penelitian ini menggunakan jenis penelitian yuridis empiris. Teknik pengumpulan data dilakukan dengan cara studi dokumen dan wawancara bersama Kaumintu Satuan Reserse Kriminal serta Penyidik dari Unit IV Tipidter Satuan Reserse Kriminal Polres Buleleng, dimana nantinya data yang diperoleh tersebut akan dianalisis secara deskriptif kualitatif. Dari hasil penelitian diperoleh bahwa Polres Buleleng dalam hal ini Unit IV Tipidter melakukan beberapa upaya didalam menindak pelaku penyebar video bermuatan asusila disertai pemerasan dan pengancaman, yakni diawali dengan melacak keberadaan pelaku kemudian koordinasi dengan kepolisian tempat pelaku berada dan melakukan penangkapan kepada pelaku. namun terdapat kendala didalam melakukan upaya tersebut, yaitu pelaku berada di daerah luar bali, menggunakan nomor telepon atau *fake* akun dan tidak adanya laboratorium *cyber*.

ABSTRACT

This study aims to determine the efforts made by Buleleng Police in handling and taking action against the perpetrators of the Dissemination of Indecent Video accompanied by Extortion and Threatening in Buleleng Regency and the obstacles faced by Buleleng Police in taking action against the perpetrators of the Dissemination of Indecent Video accompanied by Extortion and Threatening in Buleleng Regency. This research is motivated by the criminal act of spreading indecent videos accompanied by extortion and threatening which is increasingly occurring from year to year in Buleleng Regency, as well as the impact caused by the criminal act of spreading indecent videos accompanied by extortion and threatening for the wider community. This research uses empirical juridical research. Data collection techniques were carried out by means of document studies and interviews with Certain Crimes of the Criminal Investigation Unit and Investigators from Unit IV Certain Crimes of the Buleleng Police Criminal Investigation Unit, where later the data obtained will be analyzed descriptively qualitatively. From the results of the study it was found that the Buleleng Police in this case Unit IV Certain Crimes made several efforts in taking action against the perpetrators of the Dissemination of Indecent Videos accompanied by Extortion and Threats, namely starting with tracking the whereabouts of the perpetrators then coordinating with the police where the perpetrators were and arresting the perpetrators. but there are obstacles in making these efforts, namely the perpetrators are in areas outside Bali, Using Phone Numbers or Fake Accounts and the Absence of a Cyber Laboratory.
