**ABSTRAK**

Penelitian ini memiliki bertujuan untuk (1) memberikan pemahaman mengenai Peranan Kepolisian dalam mencegah penyalahgunaan narkotika di lingkungan Aparatur Sipil Negara Kabupaten Buleleng, serta (2) mengetahui Bagaimana hambatan dan tantangan yang di hadapi Satuan Reserse Narkoba Polres Buleleng terkait pencegah penyalahgunaan narkotika di lingkungan Apartur Sipil Negara Kabupaten Buleleng. Jenis penelitian yang digunakan adalah penelitian hukum empiris, dengan sifat penelitian deskriptif. Lokasi penelitian ini dilaksanakan di Kepolisian Resor Buleleng. Teknik pengumpulan data yang digunakan adalah dengan cara studi dokumen, observasi dan wawancara. Teknik pengumpulan sampel yang digunakan adalah Teknik purposive sampling. Teknik pengolahan dan analisis data yakni dilakukan secara kualitatif. (1) Hasil penelitian menunjukkan bahwa peranan Satuan Reserse Narkoba Polres Buleleng dalam mencegah penyalahgunaan narkotika dengan melakukan pembinaan, pencegahan serta penindakan di lingkungan Aparatur Sipil Negara. (2) Dalam melaksanakan pencegahan di lingkunan Aparatur Sipil Negara Satuan Reserse Narkoba Polres Buleleng mengalami hambatan serta tantangan seperti kurangnya jumlah aparat terkait dalam memberantas tindak pidana narkotika serta kurangnya partisipasi masyarakat dalam mencegah penyalahgunaan narkotika di lingkungan Aparatur Sipil Negara.

***ABSTRACT***

*This study aims to (1) provide an understanding of the Role of the Police in preventing drug abuse in the Civil Service of Buleleng Regency, and (2) find out what obstacles and challenges are faced by the Buleleng Police Narcotics Research Unit related to preventing drug abuse in the Civil Service of Buleleng Regency. The type of research used is empirical legal research, with a descriptive research nature. The location of this research was carried out at the Buleleng Police Resort. The data collection technique used was by means of document study, observation and interviews. The sample collection technique used was the purposive sampling technique. The data processing and analysis technique was carried out qualitatively. (1) The results of the study indicate that the role of the Buleleng Police Narcotics Research Unit in preventing drug abuse is by providing guidance, prevention and action in the Civil Service environment. (2) In implementing prevention in the Civil Service environment, the Buleleng Police Narcotics Research Unit has encountered obstacles and challenges such as the lack of officers involved in eradicating narcotics crimes and the lack of community participation in preventing narcotics abuse in the Civil Service environment.*
