ABSTRAK

Penelitian ini bertujuan untuk (1) mengkaji dan menganalisis terkait upaya Kepolisian Resor Buleleng dalam menanggulangi kasus pencurian sepeda motor di Kabupaten Buleleng dan (2) hambatan yang dihadapi Kepolisian Resor Buleleng dalam menanggulangi kasus pencurian sepeda motor di Kabupaten Buleleng. Data yang digunakan dalam penelitian ini meliputi data primer dan data sekunder, yang mencakup bahan hukum primer, bahan hukum sekunder, serta bahan hukum tersier. Pengumpulan data dilakukan melalui studi dokumen, observasi, dan wawancara. Teknik penentuan sampel yang diterapkan adalah *non-probability sampling*, dengan pemilihan subjek penelitian menggunakan metode *purposive sampling*. Data yang telah terkumpul kemudian diolah dan dianalisis secara kualitatif. Adapun hasil penelitian menunjukkan bahwa (1) Upaya Kepolisian Resor Buleleng dalam menanggulangi pencurian sepeda motor di Kabupaten Buleleng dengan melakukan upaya pre-emtif memasang cctv dan sosialisasi viedotron, upaya preventif yaitu melakukan deteksi terhadap wilayah-wilayah tertentu dan represif melakukan tindakan terhadap tindakan pencurian sepeda motor. (2) Hambatan yang di hadapi Kepolisian Resor Buleleng seperti kekurangan personel dan kesulitan mendapatkan barang bukti.

ABSTRACT

This study aims to (1) examine and analyze the efforts of the Buleleng Resort Police in tackling motorcycle theft cases in Buleleng Regency and (2) the obstacles faced by the Buleleng Resort Police in tackling motorcycle theft cases in Buleleng Regency. The data used in this study includes primary and secondary data, which covers primary legal materials, secondary legal materials, and tertiary legal materials. Data collection was conducted through document studies, observations, and interviews. The sampling technique applied was non-probability sampling, with research subjects selected using purposive sampling. The collected data was then processed and analyzed qualitatively. The results of the study indicate that (1) The Buleleng Resort Police's efforts to combat motorcycle theft in Buleleng Regency include pre-emptive measures such as installing CCTV cameras and conducting viedotron socialization, preventive measures such as detecting certain areas, and repressive measures such as taking action against motorcycle theft. (2) The challenges faced by the Buleleng Police Department include a shortage of personnel and difficulties in obtaining evidence.
