

**TINDAKAN KEPOLISIAN DALAM UPAYA PENANGGULANGAN
PENYALAHGUNAAN NARKOTIKA DI DESA PETEMON KECAMATAN

ABSTRAK

Penelitian ini bertujuan untuk (1) mengetahui dan menganalisis tindakan kepolisian Sektor Seririt dalam upaya penanggulangan penyalahgunaan narkotika di Desa Petemon serta (2) mengetahui dan menganalisis faktor penghambatan kepolisian Sektor Seririt dalam upaya penanggulangan penyalahgunaan narkotika di Desa Petemon. Metode penelitian yang digunakan adalah penelitian hukum empiris dengan sifat penelitian deskriptif. Data dan sumber data yang digunakan meliputi data primer dan data sekunder, yang terdiri atas bahan hukum primer, bahan hukum sekunder, dan bahan hukum tersier. Teknik pengumpulan data yang diterapkan mencakup studi dokumen, observasi, serta wawancara. Adapun teknik penentuan sampel yang digunakan adalah *non-probability sampling*, dengan subjek penelitian ditentukan menggunakan teknik *purposive sampling*. Hasil penelitian menunjukkan bahwa (1) mekanisme penyelesaian tindakan kepolisian dalam upaya penanggulangan penyalahgunaan narkotika di Desa Petemon, Kecamatan Seririt, mencakup pendekatan pre-emptive melalui pembinaan masyarakat, preventif dengan mengutamakan pencegahan sesuai asas hukum kepolisian, dan represif dalam bentuk penindakan hukum, yang seluruhnya dilaksanakan melalui sinergi antara kepolisian, masyarakat, dan lembaga terkait guna menciptakan efek jera, menekan angka penyalahgunaan, serta meningkatkan kesadaran hukum dan kualitas hidup masyarakat setempat (2) Hambatan kepolisian dalam upaya penanggulangan penyalahgunaan narkotika di Desa Petemon, Kecamatan Seririt, meliputi rendahnya kesadaran dan partisipasi masyarakat, keterbatasan sarana dan prasarana pendukung, kurangnya keterlibatan elemen strategis masyarakat, serta penyuluhan yang belum efektif dan belum menjangkau seluruh lapisan, terutama di wilayah pedesaan.

ABSTRACT

This study aims to (1) identify and analyze the actions taken by the Seririt Police Sector in combating drug abuse in Petemon Village and (2) identify and analyze the factors hindering the Seririt Police Sector in combating drug abuse in Petemon Village. The research method used is empirical legal research with a descriptive nature. The data and data sources used include primary and secondary data, consisting of primary legal materials, secondary legal materials, and tertiary legal materials. The data collection techniques applied include document study, observation, and interviews. The sampling technique used is non-probability sampling, with the research subjects determined using purposive sampling. The results of the study show that (1) the mechanism for resolving police actions in efforts to combat narcotics abuse in Petemon Village, Seririt District, includes a pre-emptive approach through community development, a preventive approach that prioritizes prevention in accordance with the principles of police law, and a repressive approach in the form of law enforcement, all of which are carried out through synergy between the police, the community, and related institutions to create a deterrent effect, reduce the rate of abuse, and improve legal awareness and the quality of life of the local community. (2) The obstacles faced by the police in their efforts to combat drug abuse in Petemon Village, Seririt District, include low community awareness and participation, limited supporting facilities and infrastructure, lack of involvement of strategic community elements, as well as ineffective outreach that has not reached all segments of society, especially in rural areas.
