## **Abstrak**

Penelitian ini bertujuan untuk mengetahui; penyebab kredit macet, sistem pengendalian internal yang diterapkan, dan penerapan sanksi adat *Rampag* menjadi sistem pengendalian internal pada LPD Desa Adat Padangbulia. Metode kualitatif merupakan metode yang digunakan dalam riset ini dengan data primer dan data sekunder. Temuan riset ini menunjukkan terdapat beberapa hal yang menyebabkan kredit macet pada LPD Desa Adat Padangbulia, sistem pengendalian internal pada LPD Desa Adat Padangbulia berpedoman pada *awig-awig* LPD Desa Adat Padangbulia yang dibuat berdasarkan kesepakatan *krama* desa, dan sanksi adat *Rampag* merupakan sanksi berupa pelelangan dan pemberhentikan sebagai *krama* desa bagi *krama* yang mengalami kredit macet dan sanksi tersebut efektif dalam menurunkan jumlah kredit macet di LPD Desa Adat Padangbulia.

*This study aims to determine; the causes of bad loans, the internal control system implemented, and the implementation of the Rampag customary sanctions as an internal control system at the Padangbulia Traditional Village LPD.
